### Policy Statement

Students at the Medical College of Georgia enrolled in programs that have a clinical education component are required to be covered by Professional Liability Insurance.

### Reason For Policy

Students in the health professions are required to participate in various clinical learning experiences as a prerequisite to successful completion of programs of study. Many of the clinical facilities where these learning experiences take place will only accept students who are covered by professional liability insurance. Therefore the Medical College of Georgia requires students enrolled in programs with a clinical component to be covered by professional liability insurance.

### Entities Affected By This Policy

All students at the Medical College of Georgia who are enrolled in programs that have a clinical education component for completion of the degree requirements are covered by this policy.

### Who Should Read This Policy

All health profession students at the Medical College of Georgia and the faculty who teach them should be aware of this policy.

**Overview**

Cashier's Office	Assess appropriate fee to students' bills
